# **Legislative Update**

HB 282\* Generally revises rental laws

 One provision: When served with court ordered eviction paperwork, renters now have only 5 business days to respond

HB 488\* Revises security deposit law

 Makes it easier for landlords to keep a renter's security deposit when the landlord has a lawsuit pending against the renter

HB 19 Revises laws related to Indian affairs and economic development

HB 317 Provide for the Montana Indian Child Welfare Act

 Codifies federal protections for Native American children, families and tribal nations in state law

HB 790 Generally revises laws related to electronic monitoring of accused persons and updates crime victim notification of these monitoring systems

SB 99 Provide for a youth health protection act

Prohibits gender-affirming medical and surgical care for transgender minors

HB 303 Implement Medical Ethics and Diversity Act

 Allows medical providers and institutions to withhold services based on ethical, moral, or religious beliefs

HB 359 Prohibits minors from attending drag shows and limits where drag shows can be performed

SB 458 Defines sex in Montana law

\*Starred bills became law when passed. All other bills go into effect on the date provided in the bill language.
